- VII. UNFINISHED BUSINESS
  - A. <u>Ordinance 24-130 Amending Chapter 4 Alcohol (2<sup>nd</sup> Reading)</u> *The amendments* to this ordinance include setting the limit of annual Consumption and Display permits issued as well as the number of off-sale liquor store licenses. The City Manager and

City Clerk recommends the number of consumption and display annual permits be limited to a total of two (2) and the number of off-sale liquor licenses be limited to a total of eight (8). Additionally, Article VII. related to Social Hosts and Underage Drinking has been removed from Chapter 4 and added to Chapter 22 – Health. Staff recommends approval of this final reading.

It has also been noted that an off-sale business that is currently licensed will be permitted to sell to a new owner and continue operating as an off-sale liquor store in the same location.

The question on "are we creating an advantageous or disadvantageous business model" has been raised. All I can say is that if we have a serious business owner coming requesting to install a ninth (9<sup>th</sup>) liquor store (or any other), they would only do so if the community was leaking sales to other communities. Most small businesses cannot take an aggressive or hostile stance pushing somebody else out. If we start to hear requests, we should listen and evaluate. We can trust that our role as a licensing agency is not going to interfere with the market unless we flatly ignore such requests. Right now, what we have is a long standing request from the business owners themselves and the public during the moratorium hearings to set limits on the number of licenses.

B. Ordinance 24-131 Amending Chapter 12 – Businesses and Business Regulations – Plumbers, Sexually Orientated Businesses (SOB), Tobacco, Transient Merchants, and Water Softener and Water Filtering Equipment Installers (2<sup>nd</sup> Reading) – The changes to Chapter 12, as recommended by the City Clerk, are as follows:

**Article VII. Plumbers** is repealed in its entirety as State licensing laws specifically prohibit local licensing of plumbing contractors and are currently regulated under the City's standard building code.

Article VIII. Sexually Oriented Businesses (SOB) include limiting the number to no more than one (1) SOB in City limits. It is also noted that a currently licensed SOB may be sold to another owner and continue operating in the same location. The definition of Adult Entertainment Establishments has also been added.

**Article XII. Tobacco**: The amendments related to tobacco include the definition of a Smoke Shop/Tobacco Store and setting the limit to no more than two (2) of this type of business, while once again, noting that a currently licensed Smoke Shop/Tobacco Store will be permitted to sell the business to a new owner and continue operating in the same location.

Article XIII. Transient Merchant applicants will be required to undergo a background check at time of application, and pay the investigation fee as found in the City's annual fee schedule.

*Article XIV. Water Softener and Water Filtering Equipment Installers* is repealed in its entirety. These are currently regulated under the City's standard building code. Staff recommends approval of this final reading.

There are organizations that are requesting the number of tobacco and smoke shops be reduced back to the recommended two (2) that exist now. The need for certain products and paraphernalia with cannabis or other does not require a tobacco/smoke shop license. Many cannabis retailers will have the same paraphernalia as the tobacco stores. The ability to sell many of the same products to the general public does not meet the limitation definition of two (2) as in example gas stations. It is the primary businesses activity of selling tobacco products that is limited by two (2) or four (4) depending on what Council approves. Going less than two (2) is not recommended given the existing businesses and one being in a nonconforming location.

C. <u>Ordinance 24-132 Amending Chapter 22 – Health (2<sup>nd</sup> Reading)</u> – Article VII. related to Social Hosts and Underage Drinking is being removed from Chapter 4 and added to Chapter 22. Additionally, language has been added to include "Cannabis" where alcohol is noted, as well as adding the definition of Cannabis. Approval is recommended. Staff recommends approval of this final reading.

#### VIII. NEW BUSINESS

A. <u>Resolution Declaring No Public Interest in Real Property – 821 Jefferson Avenue</u> – Now that the majority of the serious blight and hazardous issues with the property are resolved, it is no longer of public interest to hold the property. It is in the public's interest to place it in private hands so that it may be remodeled into 3 safe housing units. City Manager recommends approval.

B. <u>Resolution Approving Development Agreement for 821 Jefferson Avenue</u> – The purchase agreement will require the property be redeveloped. The City Manager has met with the developers to go over their plans and more. The developers have a positive history in Albert Lea on improving property conditions. The purchase price of \$30,000 is about equal to all repairs to the property. The development agreement will reflect the attached proposal.

C. <u>Resolution Approving Variance From Height Limitations – Green Acres Milling</u> – *The* Board of Appeals found that the property met the legal standards set forth by MN Statute 462.357 which includes a practical difficulty in regards to circumstances not created by the landowner and that the height of the proposed structure is not out of size or character with other similar utility structures within the city of Albert Lea. The Board of Appeals recommends approval of the variance.

The Board of Appeals met on November 20, 2024 to conduct a public hearing to consider a Variance application from Green Acres Milling to building an oat milling operation which includes a warehouse, storage bins and elevator that exceeds maximum height limitations.

Current city code states that there shall be a maximum height limitation of one thousand four hundred (1.400) feet MSL for all structures or parts of structures in any location or zoning district.

The proposed development has a finished floor elevation of 1,301 feet MSL, and a building and equipment height of 1,441.5 feet MSL which requires a 41.5 foot variance.

Finished floor elevation of 1,301 feet MSL Building height of 115 feet or 1,416 MSL Equipment height of 25.5 feet or 1,441.5 MSL

D. <u>Resolution Authorizing Signing 2024 Lead Service Line Replacement Project</u> <u>Contracts – Job 2412</u> - The project involves replacement of lead service lines throughout the City. The City has secured grants to pay for the lead service line replacements.

Because this is a new program (Albert Lea is third in state to receive) it is taking longer to get agreements in place. The City has signed the State of Minnesota Lead Service Line Replacement Program Master Loan (Bond Purchase) and/or Grant Agreement – Albert Lea\_LSLR\_00 but do not anticipate the bonding portion of the agreements to be in place until December.

Staff is asking to proceed with signing of the contractor agreements and proceeding with the work prior to the bond funding being in place. This is allowed by the Public Facilities Authority.

On June 10, 2024 Council passed Resolution 24-111 that awarded bids to two low bidders, Platinum Plumbing Solutions, LLC of Albert Lea for bid packages 1, 3 and 5, and BCM Construction, Inc. of Faribault MN for bid packages 2 and 4.

The awards were approved based on the following: Sec 1. Bids are accepted by the City of Albert Lea contingent upon grant funding being awarded.

The contractors are wanting to get started on the work and are asking for authorization to proceed.

A roll call is recommended.

#### NEW BUSINESS

A. Public Hearing on Proposed Assessments for the 2024 Neighborhood Improvement Project

(Job 2401)

Mayor Murray opened the public hearing. He called the first time and David Allen Brackey approached the podium to present his opposition to his street assessment on Fairlane Terrace. He also submitted a written appeal to the City Clerk. Mayor Murray called a second time and Robert Bastian is new to the community and asked why city taxes did not cover street assessments. Mayor Murray called a third time. Samantha Lien spoke of her confusion regarding how the street improvements were done this year and heard that more improvements would be done next year. She asked if she would be assessed twice. No one else spoke. Mayor Murray closed the public hearing.

City Manager Rigg described the assessment policy including the deferment process.

# A1. Resolution 24-199 Adopting Final Assessments for the 2024 Neighborhood Improvement Project (Job 2401)

This resolution would adopt the final assessments for City Job No. 2401. This project involved overlays, curb & gutter, and water main replacement, in the following locations: Fairlane Terr, Crestview Rd, Spicer Rd, Foothills Blvd, Briarwood Dr, Kent Ave, Levison St, and Columbus Ave. Following the Assessment Policy, the assessments for the overlay area and Spicer Road will be over ten years and over fifteen years for the Hammer Road Reconstruction portion. The interest rate will be 5.71%.

#### Neighborhood Improvement Overlay and Curb & Gutter Replacement

This portion of the project involved the bituminous overlay of residential streets in the area surrounding Fairlane Terrace. The streets are as follows:

Fairlane Terrace – Richway Drive to Crestview Road Crestview Road – Fairlane Terrace to Levison Street Spicer Road – Fairlane Terrace to Foothills Boulevard Foothills Boulevard – Fairlane Terrace to Crestview Road Briarwood Drive – Garfield Avenue to Fairlane Terrace Kent Avenue – Fairlane Terrace to Levison Street Levison Street – Garfield Avenue to Crestview Road Columbus Avenue – Hawthorne Street to Crestview Road

The project involved milling the existing bituminous street surfacing for a 6-foot width along each concrete gutter line so the new bituminous layer matched the level of the concrete gutter. A 2-inch-thick layer of bituminous was laid over the entire width of the street. The project also involved miscellaneous curb & gutter replacement to address drainage problems and to correct severely deteriorated curb.

#### Bituminous Surface Construction & Watermain Replacement

The project involved replacing the watermain with plastic pipe including the residential services, and installing new curb & gutter and street pavement on Spicer Road from Fairlane Terrace to the cul-de-sac.

#### Bituminous Surface Reconstruction – Hammer Road East End

The pavement on the dead-end section at the east end of Hammer Road was in poor condition. The existing pavement was removed, the existing aggregate road base was reshaped and recompacted, and a new bituminous surface was installed.

Motion made by Councilor Christensen, seconded by Councilor Anderson. On roll call vote, the following councilors voted in favor of said motion: Councilor Christensen, Baker, Howland, Rasmussen, Anderson, and Mayor Murray.

B. Public Hearing on Proposed Assessments for the 2024 State Aid Street Overlay Project (Job 2402).

Mayor Murray opened the public hearing. He called three times. No one spoke. Mayor Murray closed the public hearing.

#### B1. Resolution 24-200 Adopting Final Assessments for the 2024 State Aid Street Overlay Project (Job 2402)

Rigg said this resolution would adopt the final assessments for City Job No. 2402. This project involved the installation of new curb & gutter, sidewalks and bituminous overlay of Greenwood Drive. Following the Assessment Policy, the assessments will be over ten years with an interest rate of 5.71%. Staff recommends approval.

Work included:

- Relocation of the curb & gutter on the west side of the road to accommodate a new sidewalk
- Installation of new sidewalk along the west side of the road
- Complete replacement of the bituminous surface of approximately 200 feet of road near the Green Lea Lane intersection
- Mill bituminous 2" deep along the edges
- Place a new 2" bituminous overlay over the entire street
- Designate the east side of Greenwood Drive as "No Parking"

Motion made by Councilor Baker, seconded by Councilor Anderson. On roll call vote, the following councilors voted in favor of said motion: Councilor Christensen, Baker, Howland, Rasmussen, Anderson, and Mayor Murray.

This resolution would adopt the final assessments for City Job No. 2403, the Marshall Street & Sibley Avenue Reconstruction Project. Work included the complete removal and replacement of the pavement, curb & gutter, sidewalk, sanitary sewer, storm sewer, and watermain. Following the Assessment Policy, the assessments will be over fifteen years with an interest rate of 5.71%.

Motion made by Councilor Anderson, seconded by Councilor Rasmussen. On roll call vote, the following councilors voted in favor of said motion: Councilor Christensen, Baker, Howland, Rasmussen, Anderson, and Mayor Murray.

D. Public Hearing on Proposed Assessments for the 7th Street & Winter Avenue Reconstruction Project (Job 2404).

Mayor Murray opened the public hearing. Tereasa Alsadi spoke of her opposition regarding the assessment on her deceased mother's property. She explained she has attempted to donate the home at her mother's request to no avail. She submitted a letter appealing the assessment charges. Mayor Murray called a second time. Virgil Loge asked why the assessments are adopted when the job is not complete, as well as how are the assessment charges determined. He also commented on the lack of sod and parking signs that have not yet been replaced. Additionally, he requests a "Children at Play" sign be installed. He submitted an appeal letter to the City Clerk. Mayor Murray called a third time. No one spoke. Mayor Murray closed the public hearing.

To Councilor Anderson's questions, Jahnke explained the sod was not seeded due to the preferred processes on behalf of the contractor. The sod will be completed by next spring. Additionally, Jahnke responded that the reason for waiting to apply the second layer of bituminous material is to ensure proper settling before applying the second layer in the spring. Jahnke confirmed for Councilor Baker that there is a 30-day warranty on the newly placed sod.

# D1. Resolution 24-202 Adopting Final Assessments for the 7th Street & Winter Avenue Reconstruction Project (Job 2404)

This resolution would adopt the final assessments on November 12, 2024 for City Job No. 2404, the 7<sup>th</sup> Street & Winter Avenue Reconstruction Project. Following the Assessment Policy, the assessments will be over 15 years with an interest rate of 5.71%. Staff recommends approval.

This project involved complete reconstruction of the following streets:

7th Street – SE Broadway Avenue (TH-65) to James Avenue Winter Avenue – Fountain Street to Abbott Street

Work included the complete removal and replacement of the pavement, curb & gutter, sidewalk, sanitary sewer, storm sewer, and watermain.

7th Street was narrowed to accommodate a new sidewalk on the north side of the road.

Motion made by Councilor Baker, seconded by Councilor Anderson. On roll call vote, the following councilors voted in favor of said motion: Councilor Christensen, Baker, Howland, Rasmussen, Anderson, and Mayor Murray.

The sanitary sewer manholes within the alleys were repaired and lined. Following the Assessment Policy, the assessments will be over ten years with an interest rate of 5.71%.

### F1. Resolution 24-204 Adopting Final Assessments for Delinquent Water/Sewer Accounts and Miscellaneous Accounts Receivables

This resolution would adopt the final assessments for delinquent water/sewer accounts and delinquent accounts receivable per the Code of Ordinances. These assessments are payable with terms of one year at 5.71% interest.

Councilor Baker commented on the positivity of the new business development in the community.

Mayor Murray spoke of his support of this development noting the addition will help grow the city's tax base. He also stated this is a big investment this firm is making in the community while adding jobs and more people while adding this a good agricultural project supporting local farmers.

# G1. Resolution 24-205 Authorizing Execution of a Development Agreement and Approval of Business Subsidy

Requires the developer to pay \$20,000 The attached Resolution authorizes the City to enter into a Development Agreement with Ivy & Karma, Inc DBA Green Acres Milling to assist with financing for certain costs incurred in connection with the construction of an oat mill processing facility. The City of Albert Lea held a public hearing in regard to the TIF plan in June of this year but because the full terms of the subsidy and subsequent agreement were not completed an additional public hearing has to be held.

City Manager Rigg said the attached agreement outlines:

- A total TIF incentive of \$741,600 payable starting on August 1, 2027
- The creation of 12 jobs within two years at a yearly wage of \$100,000 inclusive of benefits
- Agreement for ALEDA to sell the property at a reduced price of \$300,000 which is a land write down of \$300,000

 Requires the developer to pay \$20,000 in a TIF deposit for costs incurred in the creation of the district

# H. Resolution 24-206 Accepting Bid and Awarding Contract for the Blazing Star Landing NE Corner 6 Acre Site Remediation (Job 2416)

Engineering and Braun Intertec have reviewed the bids opened Friday, November 1, 2024 for the Blazing Star NE Corner Site Remediation Project. The project involves excavation and disposal of contaminated soil, and import and placement of clean soil throughout the site to prepare the site for building. Engineering received 8 bids, recommending the low bid of \$326,060.00 as submitted by Jensen Excavating & Trucking LLC of Albert Lea, Minnesota. The bid abstract is attached. The Engineer's estimate was \$385,500. This project is partially funded with a DEED grant of approximately \$130,527.00.

It has also been noted that an off-sale business that is currently licensed will be permitted to sell to a new owner and continue operating as an off-sale liquor store in the same location.

Councilor Christensen asked staff to reiterate what was explained at the work session regarding how these limitations were determined. City Manager Rigg expounded on previous discussions with council and staff during the recent moratorium related to creating parity in the limit of cannabis businesses and off-sale businesses as well as the commonality in many cities where limits are enforced and consumption and display permits are not allowed. Councilor Christensen relayed that she has had constituents contact her in opposition of setting these limits. She encourages residents to contact council members and provide input. Council Anderson echoed Christensen's remarks.

Motion made by Councilor Howland, seconded by Councilor Baker. On roll call vote, the following councilors voted in favor of said motion: Councilor Christensen, Baker, Howland, Rasmussen, Anderson, and Mayor Murray.

### J. Ordinance 24-131 Amending Chapter 12 – Businesses and Business Regulations (1<sup>st</sup> Reading)

The changes to Chapter 12, as recommended by the City Clerk, are as follows:

**Article VII. Plumbers** is repealed in its entirety as State licensing laws specifically prohibit local licensing of plumbing contractors and are currently regulated under the City's standard building code.

**Article VIII. Sexually Oriented Businesses (SOB)** include limiting the number to no more than one (1) SOB in City limits. It is also noted that a currently licensed SOB may be sold to another owner and continue operating in the same location. The definition of Adult Entertainment Establishments has also been added.

**Article XII. Tobacco**: The amendments related to tobacco include the definition of a Smoke Shop/ Tobacco Store and setting the limit to no more than two (2) of this type of business, while once again, noting that a currently licensed Smoke Shop/Tobacco Store will be permitted to sell the business to a new owner and continue operating in the same location.

**Article XIII. Transient Merchant** applicants will be required to undergo a background check at time of application, and pay the investigation fee as found in the City's annual fee schedule.

**Article XIV. Water Softener and Water Filtering Equipment Installers** is repealed in its entirety. These are currently regulated under the City's standard building code.

Councilor Howland commented that with the legalization of cannabis and more and more people using electronic cigarette devices/vapes, there is opportunity for growth for local businesses and therefore, believes increasing the limit to four (4) Smoke Shop/Tobacco Stores will support these types of businesses. In response to Councilor Anderson's question, Rigg said he will provide the zoning information related to these types of businesses at the next council meeting prior to the second reading on November 25<sup>th</sup>.

Motion made by Councilor Howland to amend the first reading of this ordinance by changing the limit of Smoke Shop/Tobacco Stores to four (4), seconded by Councilor Anderson. On roll call vote, the following councilors voted in favor of said motion: Councilor Christensen, Baker, Howland, Rasmussen, Anderson, and Mayor Murray.

### REVIEW 2025 FEE SCHEDULE CHANGES AND 2025 WATER, SEWER, SOLID WASTE, AIRPORT AND SENIOR CENTER BUDGETS

Finance Director Brutlag began by explaining how the 2025 Fee schedule is updated. She said each department head began reviewing items on the fee schedule months in advance to ensure fees remain in accordance with statute, value, and standard rates. Brutlag and City Manager Rigg highlighted some of the changes including fees for callbacks related to Fire Inspections, and the matrix in fees for building permits. Rigg noted changes in tobacco and alcohol fees will come forth in March or April. Howland mentioned there seem to be far more changes in fees this year than in past years to which Brutlag replied each department did an extra thorough review of each and every item on the fee schedule. Councilor Christensen said she appreciates the small incremental changes made each year as necessary as opposed to a large increase at one time. Malakowsky responded to Councilor Anderson's question regarding the increased fee for the rental of the Edgewater Bandshell. She explained the rental fees are based on actual use that includes setup and take down. She also reviewed the additional recreation fees that were updated.

Brutlag displayed a presentation outlining the 2025-2029 budget review. Her slides included an overview of the 2019-2025 water & sewer rates, a comparative residential monthly utility bill chart, as well as an overview of the water and sewer funds, solid waste, Airport, and the Senior Center funds. She noted the increase of 5% in water rates and 7% in sewer rates in 2025. Brutlag described a \$30 million public works project proposed for 2029 that may require water and sewer rate increases starting now and continued increases each year leading up to the project to avoid an engorged increase in any one year, as recommended by the recent water rate study. Rigg further described the necessity of this project and the importance of maintaining awareness of the impact on water and sewer rates. Additionally, Howland acknowledged the need to remain mindful of the \$80 million waste water treatment plant upgrade. Jahnke said the city has a new account representative at Waste Management and he was able to negotiate new landfill rates with a savings of 15% next year. He also described the lull in Airport projects and explained the next

three years will remain in a lull as they try to save up to build three new hangars. Brutlag went on to explain the Senior Center fund is nearly depleted and anticipates supplementing the Senior Center with the Levy within the next couple of years. She noted the current proposed budget will change once the final open enrollment numbers for health benefits are determined for 2025. The final budget, CIP, and Fee Schedule are scheduled for council approval at the December 9<sup>th</sup> council meeting.

Christensen said she received a call from a constituent inquiring why the off-sale liquor license is being limited to eight. Rigg explained the limitation is in an effort to create parity as with cannabis licensing. Clerk Maras added that eight liquor stores in a community of 18,000 is already a hefty number. Christensen asked for a description of a Consumption and Display permit, to which Rigg deferred to Clerk Maras. She explained this permit is allowed without liquor liability and lacks rules as required with on-sale and off-sale liquor licenses, which makes issuing these permits somewhat of a liability for cities. Anderson spoke of his opposition to limiting the number on these businesses. Rigg said the intent is in consideration to the public health and community. Limitations are important to apply however, if council chooses not to create limitations or wish to expand them, that is ultimately up to them. Baker added if we lift the limit on off-sale, then it would only be fair to lift the limit on cannabis. Christensen said she is glad this conversation is taking place now to ensure a better understanding.

J. Ordinance Amending Chapter 12 – Businesses and Business Regulations (1<sup>st</sup> Reading)

Clerk Maras clarified for Christensen that Albert Lea currently only licenses one Sexually Oriented Business and warehouses that sell similar products are not considered the same.

Regarding the limitation of two Tobacco Shops, Howland spoke of his opposition to limiting to just two as he believes there is opportunity for growth. Rigg reiterate this, too, is council's decision to

set limits or lift the limits. Rigg confirmed for Baker that a person is, at any time, allowed to ask council to raise the limitation at any time. Howland noted the common rule in cities to set limitations on the number of certain businesses and agrees this important beneficial approach, however believes setting the limit to just two Tobacco Shops is too low.

**CALL TO ORDER AND ROLL CALL** – Mayor Murray called the meeting to order at 5:30 p.m.

**INTRODUCTIONS** – Introductions took place by all those in attendance.

#### **DISCUSSION ITEMS**

A. CIP Discussion

#### i. 2025 Project Focus (Brutlag)

Finance Director Brutlag displayed a PowerPoint highlighting the 2025-2029 CIP projects that total \$188,875.000, and emphasized the CIP is a plan and can change based on need and availability of resources. She noted council authorizes the City Manager to grant approval to proceed with projects \$100,000 or less while requiring council approval if 20% of the original CIP amount or the funding source changes. The 2025 projects over \$100,000 requires approval by council resolution and any projects in 2026-2029 moved to 2025 also requires council approval by resolution. Brutlag noted tonight's focus will be on the 2025 projects.

She highlighted noteworthy Park and Public Works projects, as well as other projects within departments. Brutlag and Rigg responded to Howland's questions related to funding with grants for certain park upgrades and described the proposed upgrades to the Pickleball/Tennis Court reconstruction. To Mayor Murray's question, Jahnke replied the lifespan of playground park equipment is 20-25 years.

It was noted the 2025 Street Department projects reflect fewer projects than in most years. Jahnke explained this was intentional as the two Main Street projects consumed the majority of

the State Aid funds, therefore 2025 will be used to rebuild those funds for future projects. Jahnke described the plan, as discussed with MNDOT, for the Railway Trail from Fountain Street to Highway 13 toward Manchester, as well as the reliance on Federal and State grants. Rigg provided an overview of the Blazing Star proposed projects including street reconstruction, utilities, and funding. Other projects including large vehicles were discussed as council and staff exchanged dialogue. Brutlag gave an overview of City Center Projects including the City Center improvements and Library expansion. She then displayed a slide revealing a synopsis of the debt levy from 2025-2030. The Public Works Phase 2 City Garage project is the largest on the list and has been pushed back year after year. However, Rigg explained the necessity of the upgrades to the facility to be able to continue to maintain functionality. To Mayor Murray's question and concern of increased taxes on residents as a result of these large projects, Brutlag responded it is difficult to determine the future tax rate when the tax capacity cannot be determined from one year to the next. The hope is the tax capacity is increased each year from new businesses and new homes so the impact is less on local taxes. Councilor Christensen noted her concerns of over taxing Albert Lea residents and pronounced the importance of determining the need of what is absolutely necessary and valuable to residents. Baker remarked that although the CIP projects are expensive, inflation continues to increase and the longer projects are put off, the more expensive they become in the long run. Jahnke interjected that if the vehicles used at the Street Department are, in fact, eventually replaced with electric as has been proposed, the necessity of the City Garage construction project will not be an option, but rather a necessity. Lastly, Brutlag displayed a slide revealing the Levy Rate Trend from 2013-2025 implying the levy averaged an increase of 5% every year. Rigg stated, overall, the levy has remained steady over the last 12 years. Brutlag described the fund analysis tool used in determining the best funding source to pay for projects.

#### ii. City Hall 2025 - I & II (Rigg)

City Manager Rigg displayed a PowerPoint illustrating a proposed City Hall Project. He described the history of proposals involving: in 2020 - converting the old fire quarters noting that until 2021, no broad outlook to the building was applied. The first cost estimates in 2021 were \$4M-\$6M which included library expansion that ultimately were reduced to \$3.3M-\$4.2M. He explained grants were sought but denied likely due to the City Hall component. Since then, staff continued to look for cheaper alternatives or alternative revenues while the focus remained on security, efficiency, and wellness. He presented several different options in an effort to bring the cost down including splitting City Hall from the Library for a better impact if alternative funds are used. He highlighted security components, efficiencies of the upper and lower floors, and wellness factors to create a healthier environment for staff. Restrooms allowing only staff access and public restrooms were explored. Floor plan slides were displayed reflecting the proposed changes on each floor at City Hall.

Rigg cited potential Library funding options including implementing a local sales tax in 2026. A Levy for the City Hall remodel/upgrade at approximately \$1.2M-\$1.6M total cost creating a 4% levy increase over 20 years. In conclusion Rigg imparted the importance of thinking long term to understand what the delay does and what it has done to backlog need. He spoke of the financing strategies to meet any internal and external intolerances on levy spikes.

B. Tax Increment Finance Districts

#### i. Update and Future Districts (Boeck, Johnson)

City Planner Boeck described Tax Increment Financing (TIF) as an economic development tool that the State of Minnesota has developed to assist cities in incentivizing development through increment of new taxes created on projects. She provided an update on some of the successes of TIF Districts. She delivered an update on various TIF Districts accrued over the last five years and provided background on the option of paying existing TIF notes vs decertifying and described the benefits of each.

Economic Development Director Johnson emphasized that TIF is the number one incentive the city can use not only to encourage new businesses, but also for utilizing future funding to help incentivize future growth projects. He spoke of the importance of using certain parameters such as TIF and Tax Abatement to utilize and continue to grow infrastructure, future housing and development parks to prevent a never-ending cycle of delaying projects. He declared without TIF, housing projects and new developments will become nearly impossible to attain.

City Manager Rigg concluded by summarizing future projects and difficulties while offering solutions.

#### Introduced by Councilor

#### AN ORDINANCE AMENDING CHAPTER 4 ALCOHOLIC BEVERAGES

THE CITY COUNCIL OF ALBERT LEA, MINNESOTA ORDAINS:

#### ARTICLE IV. LIQUOR

#### Sec. 4.104. Consumption and display.

- (a) *Permit required.* No business establishment or club which does not hold an on-sale intoxicating liquor license may directly or indirectly allow the consumption and display of intoxicating liquor or knowingly serve any liquid for the purpose of mixing with intoxicating liquor without first having obtained a permit in accordance with state law.
- (b) The maximum number of annual permits issued shall be limited to a total of two (2)
- (c) Eligibility for permit approval.
  - (1) The city shall approve permits issued by the commissioner of public safety to:
    - a. An applicant who has not, within five (5) years prior to the application, been convicted of a felony or of violating any section of this chapter or rule adopted under this chapter;
    - b. A restaurant;
    - c. A hotel;
    - d. An establishment licensed for the sale of three and two tenths (3.2) percent malt liquor;
    - e. A resort, as defined in Minn. Stats. § 157.15;
    - f. A club, as defined in Minn. Stats. § 340A.101, or an unincorporated club otherwise meeting that definition;
    - g. A bed and breakfast facility, as defined in Minn. Stats. § 340A.4011, subd. 1.
  - (2) A club holding an on-sale intoxicating liquor license shall not be eligible for a permit.
- (d) Authorization of permit. A permit approved under this section authorizes the establishment to permit the consumption and display of intoxicating liquor on the premises. The permit does not authorize the sale of intoxicating liquor.
- (e) *Permit expiration.* All permits approved under this section expire on March 31 of each year.
- (f) *Permit approval by city required.* A permit for consumption and display issued by the commissioner of public safety is not effective until approved by the city council.
- (g) *Inspection.* An establishment holding a permit under this section is open for inspection by peace officers who may enter and inspect the establishment during reasonable hours. Intoxicating liquor

sold, served or displayed in violation of law may be seized and may be disposed of in accordance with state law.

- (h) Lockers. A club holding a permit approved under this section may allow members to bring and keep personal supplies of intoxicating liquor in lockers on the club's premises. Every bottle kept on the premises must have attached a label signed by the member. No person under twenty-one (21) years of age may keep a supply of intoxicating liquor on the club premises.
- (i) One (1) day city permits. The city council may issue a one (1) day permit for the consumption and display of intoxicating liquor under this section to a nonprofit organization in conjunction with a social activity in the city sponsored by the organization. The permit must be approved by the commissioner and is valid only for the day indicated on the permit. The city shall not issue more than ten (10) permits under this section in any one (1) year.
- (j) Hours. No establishment approved under this section shall permit a person to consume or display intoxicating liquor or three and two tenths (3.2) percent malt liquor, and no person shall consume or display intoxicating liquor or three and two tenths (3.2) percent malt liquor between 2:00 a.m. and 8:00 a.m. on the days of Monday through Saturday, nor between 2:00 a.m. and 10:00 a.m. on Sunday.

Sec. 4.106. - Limited Off-Sale Liquor Stores

The maximum number of licensed Off-Sale Liquor stores within the City of Albert Lea shall be limited to a total of eight (8):

(1) A currently licensed off-sale liquor store may be sold to another owner and continue operating as an off-sale liquor store in the same location.

#### **ARTICLE VII. PLUMBERS**

Article VII. Plumbers is repealed in its entirety.

#### ARTCILE VIII. – SEXUALLY ORIENTED BUSINESSESS

#### Sec. 12.211. Short title.

This article shall be known as, and may be referred to as, the "Albert Lea Sexually Oriented Business Ordinance."

#### Sec. 12.212. Limited number of Sexually Oriented Businesses

No more than one (1) Sexually Oriented Business shall be licensed within the City of Albert Lea.

(1) A currently licensed Sexually Oriented Business may be sold to another owner and continue operating in the same location.

#### Sec. 12.213. Definitions.

Adult entertainment establishments mean:

- (1) a business that is open only to adults and that presents live performances that are distinguished or characterized by an emphasis on the depiction of sexual conduct or nudity;
- (2) "sexual conduct" has the meaning given in MN Stat.§617.241; and
- (3) nudity has the meaning given in MN Stat. §617.292, subdivision 3.

#### Sec. 12.214. License required.

- Sec. 12.215. Issuance of license.
- Sec. 12.216. Inspection.
- Sec. 12.217. Expiration of license.
- Sec. 12.218. Regulation of sexually oriented businesses.
- Sec. 12.219. Suspension/revocation.
- Sec. 12.220. Transfer of license.
- Secs. 12.221-12.246. Reserved.

#### ARTICLE XII. – TOBACCO

#### Sec. 12.397. Definitions and interpretations.

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Smoke Shop and Tobacco Store means any premises dedicated to the display, sale distribution, delivery, offering, furnishing, or marketing of tobacco products, or tobacco paraphernalia; provided, however that any grocery store, supermarket, convenience store or similar retail use that only sells conventional cigars, cigarettes or tobacco as an ancillary sale shall not be defined as a "smoke shop and tobacco store" and shall not be subject to the restrictions in this chapter.

#### Sec. 12.398

- (k) Limited number of Smoke Shop and Tobacco Stores. No more than four (4) smoke shop and tobacco stores shall be licensed within the City of Albert Lea.
- (I) A currently licensed Smoke Shop or Tobacco Store may be sold to another owner and continue operating in the same location.

#### **ARTICLE XIII. – TRANSIENT MERCHANTS**

#### Sec. 12.435. Investigation Fee

At the time of application, applicant shall pay to the city for each person engaged in the business of transient merchant the sum fixed in the annual fee schedule. Such fee shall be considered an investigation fee, not refundable to the applicant to cover the costs of the city in processing the application and the investigation thereof.

Secs. 12.436—12.451. Reserved.

#### ARTICLE XIV. - WATER SOFTENER AND WATER FILTERING EQUIPMENT INSTALLERS

Article XIV. Water Softener and Water Filtering Equipment Installers is repealed in its entirety.

#### ORDINANCE 24-131 (SUMMARY)

#### THE CITY COUNCIL OF ALBERT LEA, MINNESOTA ORDAINS:

On November 25, 2024 the Albert Lea City Council held a regular city council meeting and amended Chapter 12- Businesses and Business Regulations – Plumbers, Sexually Oriented Businesses (SOB), Tobacco, Transient Merchants, and Water Softener and Water Filtering Equipment Installers.

The changes to Chapter 12 are as follows:

**Article VII. Plumbers** is repealed in its entirety as State licensing laws specifically prohibit local licensing of plumbing contractors and are currently regulated under the City's standard building code.

**Article VIII. Sexually Oriented Businesses (SOB)** include limiting the number to no more than one (1) SOB in City limits. It is also noted that a currently licensed SOB may be sold to another owner and continue operating in the same location. The definition of Adult Entertainment Establishments has also been added.

**Article XII. Tobacco**: The amendments related to tobacco include the definition of a Smoke Shop/ Tobacco Store and setting the limit to no more than four (4) of this type of business, while once again, noting that a currently licensed Smoke Shop/Tobacco Store will be permitted to sell the business to a new owner and continue operating in the same location.

**Article XIII. Transient Merchant** applicants will be required to undergo a background check at time of application, and pay the investigation fee as found in the City's annual fee schedule.

**Article XIV. Water Softener and Water Filtering Equipment Installers** is repealed in its entirety. These are currently regulated under the City's standard building code.

#### AN ORDINANCE AMENDING CHAPTER 22 HEALTH

THE CITY COUNCIL OF ALBERT LEA, MINNESOTA HEREBY ORDAINS:

#### **ARTICLE III. – SOCIAL HOSTS AND UNDERAGE CONSUMPTION**

#### Sec. 22.021. - Purpose and findings.

- (a) The city council intends to discourage underage possession and consumption of alcohol and/or cannabis, even if done within the confines of a private residence, and intends to hold persons criminally responsible who host events or gatherings where persons under twenty-one (21) years of age possess or consume alcohol regardless of whether the person hosting the event or gathering supplied the alcohol.
- (b) The city council finds that:
  - (1) Events and gatherings held on private or public property where alcohol and/or cannabis is possessed or consumed by persons under twenty-one (21) years of age are harmful to those persons and constitute a potential threat to public health requiring prevention or abatement.
  - (2) Prohibiting underage consumption acts to protect underage persons, as well as the general public, from injuries related to alcohol and/or cannabis consumption, such as alcohol and/or cannabis overdose or alcohol and/or cannabis related traffic collisions.
  - (3) Alcohol and/or cannabis are addictive drugs which, if used irresponsibly, could have drastic effects on those who use it as well as those who are affected by the actions of an irresponsible user.
  - (4) Often, events or gatherings involving underage possession and consumption occur outside the presence of parents. However, there are times when the parents are present and condone the activity and, in some circumstances, provide the alcohol and/or cannabis.
  - (5) Even though giving or furnishing alcohol and/or cannabis to an underage person is a crime, it is difficult to prove, and an ordinance is necessary to help further combat underage consumption.
  - (6) A deterrent effect will be created by holding a person criminally responsible for hosting an event or gathering where underage possession or consumption occurs.

#### Sec. 22.022. - Definitions.

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Alcohol means ethyl alcohol, hydrated oxide of ethyl, or spirits of wine, whiskey, rum, brandy, gin, or any other distilled spirits including dilutions and mixtures thereof from whatever source or by whatever process produced.

Alcoholic beverage means alcohol, spirits, liquor, wine, beer, and every liquid or solid containing alcohol, spirits, wine, or beer, and which contains one-half (0.5) percent or more of alcohol by volume and which is fit for beverage purposes either alone or when diluted, mixed, or combined with other substances.

Cannabis flower, cannabis products, lower-potency hemp edibles, and hemp derived consumer products shall have the meanings as defined in Minn. Stat. §342.01 (enacted under Minnesota Laws 2023).

Event or gathering means any group of three (3) or more persons who have assembled or gathered together for a social occasion or other activity.

Host means to aid, conduct, allow, entertain, organize, supervise, control, allow or permit a gathering or event.

Parent means any person having legal custody of a juvenile:

- (1) As natural, adoptive parent, or step-parent;
- (2) As a legal guardian; or
- (3) As a person to whom legal custody has been given by order of the court.

Residence or premises means any home, yard, farm, field, land, apartment, condominium, hotel or motel room, or other dwelling unit, or a hall or meeting room, park, watercraft, aircraft, or any other private or public property or place of assembly whether occupied on a temporary or permanent basis, whether occupied as a dwelling or specifically for a party or other social function, and whether owned, leased, rented, or used with or without permission or compensation.

Underage person means any individual under twenty-one (21) years of age.

#### Sec. 22.023. - Prohibited acts.

- (a) It is unlawful for any person to host an event or gathering at any residence or premises where alcohol and/or cannabis or alcoholic and/or cannabis beverages are present when the person knows that an underage person will or does consume any alcohol and/or cannabis or alcoholic and/or cannabis beverages or possess any alcohol and/or cannabis or alcoholic and/or cannabis beverages with the intent to consume it and the person fails to take reasonable steps to prevent possession or consumption by the underage person.
- (b) A person is criminally responsible for violating subsection (a) of this section if the person intentionally aids, advises, hires, counsels, consents to, allows, or conspires with or otherwise procures another to commit the prohibited act.

(c) A person who hosts an event or gathering and a person who performs acts as defined in subsection (b) of this section does not have to be present at the event or gathering to be criminally responsible.

# Sec. 22.024. - Exceptions.

- (a) This article does not apply to conduct solely between an underage person and his parents while present in the parent's household.
- (b) This article does not apply to legally protected religious observances.
- (c) This article does not apply to retail intoxicating liquor or three and two tenths (3.2) percent malt liquor licenses, municipal liquor stores, or bottle club permit holders who are regulated by Minn. Stats. § 340A.503, subd. 1(a)(1).
- (d) This article does not apply to situations where underage persons are lawfully in possession of alcohol or alcoholic beverages during the course and scope of employment.


