#### Call to Order:

The meeting was called to order by Steve Ball at 6pm.

#### Adopt Agenda:

Therese Salazar made the motion to approve the agenda for tonight's meeting and Amy Leach seconded the motion. The board voted in favor of said motion 6-0 (Whitney absent). Motion declared passed.

#### Approval of the Minutes:

Amy Leach made the motion to approve the minutes from the February 26, 2024 meeting and Therese Salazar seconded the motion. The board voted in favor of said motion 6-0 (Whitney absent). Motion declared passed.

#### **Public Items:**

Recreation staff received a project application for Grizzly Field from Ron Eriksmoen and Steve Piper, on behalf of the youth and adult football and rugby teams that utilize that facility. Staff and the board reviewed the application and agreed that this location is underutilized and making it more useful to the

user groups would be beneficial. There were a few items of concern and questions regarding the project that was discussed:

- When will the City receive the site plans being drawn up by Jones, Haugh and Smith?
- Questions on long term maintenance and the City's role, as well as the use of portable toilets and at who's expense would those be placed?
- General question on the esthetics of the containers to be used for the locker rooms/press box? Will this be appealing to the eye?
- Zoning rules and guidelines for that area, specifically setback from the lakeshore?
- Would the so-called temporary containers be viewed as private property of the user group being stored on City property and how does that fall in the City ordinance?
- Will there be a need to grade the field to level the playing surface, as well as turn the field slightly?

The board agreed that they would like to find out more answers to these questions and invite Ron and Steve to the April board meeting for further discussion.

## **Action/Discussion Items:**

- UP Rail to Trail: Ideas for naming the new trail
  - The board broke out into three small groups to brainstorm potential names to make a recommendation. Ken Rahn provided a list for the board and staff to look through. The Trails Association suggested keeping the Blazing Star Trail to have a long trail with added miles. It would also be an edge for additional funding as it would be finishing an existing trail.
  - All three groups reported back with similar responses with all of them suggesting to stay with the Blazing Star Trail. Second option ideas were Southern Star Trail and Northern Star Trail to keep with the star theme.
  - Tony Segura made the motion to recommend the naming of the new section of the trail to be the Blazing Star Trail. Therese Salazar seconded the motion. The board voted in favor of the said motion 7-0. Motion declared passed.

## • Updates on the Rec Facilities Referendum

Cathy Malakowsky provided the board with a recap of the referendum informational public meetings that have taken place so far. She also shared that the Gold Kiwanis service group donated \$500 toward the project. The final public open house will be held at the Marion Ross Theater in partnership with ACT on March 19 from 4-6p. The city has received endorsements for the referendum from the District 241 school board, Greater Jobs, CVB, Chamber of Commerce, Albert Lea Hockey Association, Albert Lea Figure Skating Club along with others.

## Staff Reports:

Ryan Hajek provided an update on the Inclusive Playground. The group has now raised \$955,000 which included the City's \$350,000 contribution. The project total is close to \$1.25 million. Playground equipment will be purchased soon. They are no longer putting up the perimeter fencing (\$02,000) and the parking lot will be delayed for now but has to be done per the City ordinance. They are also eliminating the concrete slab for portable toilets. They will also delay the water and sewer work for future bathroom. The hope is to start site prep in 2024 and purchase equipment and start the project in August.

Ryan also shared that the City received four Emerald Ash Bore contractor bids. Kent asked about how residents can identify Ash trees. There was discuss on using an app on your smart phone that can help identify by taking a picture of the tree with your phone.
